Take the IN-62 W/Lloyd Expressway ramp to IN-66 E. Turn left onto IN-66 E/E Lloyd Expressway. Continue to follow IN-66 E (8.5 miles). Turn left onto Casey Road. Destination will be on the left.

#### From I-64 (Louisville/St. Louis)

Merge onto I-164 S/I-69S/IN-57 S towards Evansville/Henderson KY (13.6 miles). Take exit 7A for East Lloyd Expressway/Indiana 66 (2 miles). Merge onto IN-66 E/E Lloyd Expressway. Continue to follow IN-66 E (3.5 miles). Turn left onto Casey Road. Destination will be on the left.
